## BREEDING CONTRACT

I hereby confirm my reservation to the stallion

**GIACOMO DI CANTERO**

Reg. BEL-W-256889-BWP

for the year 2011.

I understand and accept the following terms:

1. **FEES**

- a. **Cooled Shipping Semen:** Stud fee of \$1,500 plus 5% GST, (+ 7,5% QST in Quebec) (includes non-refundable booking fee of \$500 ). Booking fee due upon execution of this contract. Balance to be paid prior to shipment.  
Collection fee of \$250 plus 5% GST, + 7,5% QST for on-farm insemination or \$300 plus 5% GST, + 7,5% QST includes the equitainer, if shipped out, has to be paid together with the balance of the stud fee.  
Collection schedule is Monday, Wednesday and Friday and stallion owner requires 48 hours notice to set up an appointment. If you need a weekend shipment for your mare please make sure that do a Friday collection, which can be used for a Saturday or Sunday breeding.  
**The Equitainer's shipping fee is to be incurred by mare owner .** If shipped by Fed Ex, Please provide us with your Fed Ex or credit card number

- b. **Multiple mare discount :** If there are more than one mare belonging to the same owner to be bred during the same season, the 1<sup>st</sup> collection fee is free, but a \$50 is required for the Equitainer.

## 2. CONTRACT

This is a Live Foal Guarantee (LFG) contract given the following conditions:

- a. A live foal is one that stands and nurses with 4-8 hrs of foaling.
- b. A mare must have at least 3 anti-abort shots throughout the course of gestation.
- c. There must be due care taken at time of foaling.
- d. In the event of a dead foal, verbal notification must be given immediately and a veterinary certificate must be issued within 48 hours.
- e. Once the above criteria are met, a return breeding will be given, this return must be used within 2 breeding seasons.
- f. It is further agreed that should the Stallion die, be not available (competition, out of the country, injured), or become unfit for breeding, then another stallion of your choice, standing at the Ferme Beaulieu Farm and having the same stud fee, can be used.
- g. The stallion breeding certificate for registration will be issued when the mare is in foal.
- h. The stallion owner reserves the right to negate the live foal guarantee in the case of inappropriate broodmare management.

## 3. MARE CARE ON FARM

- a. You will provide a negative "Equine Infectious Anemia" (Coggins test)
- b. For Ultrasounds, A.I. or in the event of an emergency, if a veterinarian or farrier is required for mare or foal, these services will be at the mare owner's expense.
- c. Mare care at the Beaulieu Farm is \$30 (+ taxes) per day.
